ACMLA Bulletin Digitizing

In recent years, several Associations (including the Canadian Cartographic Association) have begun digitizing past issues of their respective news publications. An opportunity to begin digitizing past issues of the ACMLA Bulletin is currently being explored by First Vice President Dan Duda and staff at Memorial University. Providing electronic access to past issues will be of great benefit for the association, but may also pose challenges as well. Dan will be presenting a digitization proposal and a small sample of what we might expect from electronic back issues of the Bulletin at the Annual General Meeting. We look forward to your feedback.
